Authors affirm that the article does not contain unfounded or unlawful claims and does not violate the rights of others. If the paper includes content protected by copyright, authors warrant that they obtained a written permission for its use from copyright holders.

The copyright to this paper shall be transferred to the publisher. The author with whom correspondence is conducted (hereinafter: **the authorised author**) shall warrant that he/she is authorised to effect the transfer of copyright to the publisher.

By signing this Agreement, the authorised author shall transfer to the publisher the following rights to the manuscript, including any supplemental material, and any parts, extracts or elements thereof:

• the right to reproduce and distribute the manuscript in printed form, including print-on-demand;
